## How the programme works

Open Innovation accelerates the development towards adoption of health innovations. We support the most innovative companies to create or adapt solutions that will solve a demand-driven healthcare challenge. And implement them to gather evidence in real settings.

Every year, Open Innovation targets new healthcare challenges in different European regions. Through the process we accelerate start-ups by redefining the value proposition and business model in line with the corresponding challenge and market. We offer mentoring and coaching to support teams in creating an implementation plan for an effective validation and integration goals.

The programme will conclude with an implementation pitch presented in front of a panel of promoters including experts of clinical, business and development domains.

We're seeking promoters who:

- Can offer and share expertise and industry perspectives in the challenge area
- Are willing to dedicate time and internal resources (experts) to engage with entrepreneurs, EIT Health staff, and other experts.
- Are interested in collaborating in an implementation plan with promising start-ups coming out of the programme.



Other forms of collaboration, including hosting programme event(s), additional recognition and prize provision from the partner are also possible.

#### Important information

- We are looking for a tandem of private-public collaboration from the same region / country (e.g. a corporate and a hospital).
- Promoters will directly benefit from an Open Innovation programme (Phase I) of €250.000 cost value, proven methodology and full programme execution.
- Participating companies will be required to sign an NDA in order to ensure free exchange of information between participants, mentors & judges/evaluators.
- Piloting/Procurement solutions in Phase II: the length, activities and cost are dependent on finding a start-up to collaborate with and the implementation plan proposed. Phase II is not financed directly by EIT Health.
