- 1 Reference number of the Call for Proposals: HUHR/2401
- 2 Date of publication: 2 September 2024
- **Programme and financing source:** Interreg VI-A Hungary-Croatia Programme 2021-2027, approved by EC Decision C(2024) 1989 on 21 March 2024.
- 4 Eligible area: Supported projects are required to be implemented within the eligible area of the Programme, defined in the Interreg VI-A Hungary-Croatia Programme 2021-7 in particular in the area of three NUTS 3 regions located along the border in Hungary, four NUTS 3 regions located along the border in the Republic of Croatia and four NUTS 3 regions located along the borderline NUTS 3 Croatian regions.

Published Specific Objectives and <u>indicative</u> **funds available:** The indicative amount of **26.324.825 EUR** is available for this Call from EU contribution.

<u>The indicative financial allocations</u> for the respective Specific Objectives are listed in the table below. The final budget awarded to this Call, following the assessment of the applications, may vary based on the number of submitted applications.

Maximum project duration: 24 months

PRIORITY 4 - INCLUSIVE BORDER REGION

Available EU contribution: 16.500.000 EUR

Specific Objective (vi) – Enhancing the role of culture and sustainable tourism in economic development, social inclusion and social innovation

Maximum project duration: 24 months

Specific Objective (ii) – Improving access to inclusive and quality services in education, training and lifelong learning through developing accessible infrastructure, including by fostering resilience for distance and on-line education and training

Maximum project duration: 24 months

Specific Objective (b) – Enhance efficient public administration by promoting legal and administrative cooperation and cooperation between citizens, civil society actors and institutions, in particular with a view to resolving legal and other obstacles in border regions

Selection procedure: One-step

Maximum project duration: 24 months

Amount of EU contribution per project: 80.000 to 240.000 EUR

Specific Objective (c) - Build up mutual trust, in particular by encouraging P2P actions

1.540.825 EUR

Selection procedure: One-step

Maximum project duration: 12 months

Amount of EU contribution per project: 40.000 to 160.000 EUR
